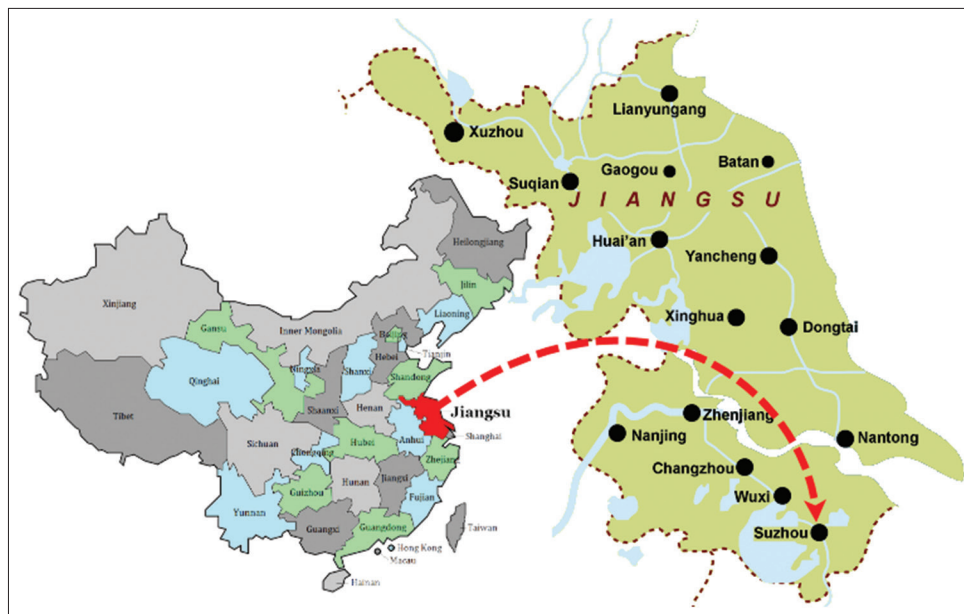


Figure 1. Map of research site in Suzhou, Jiangsu Province, China

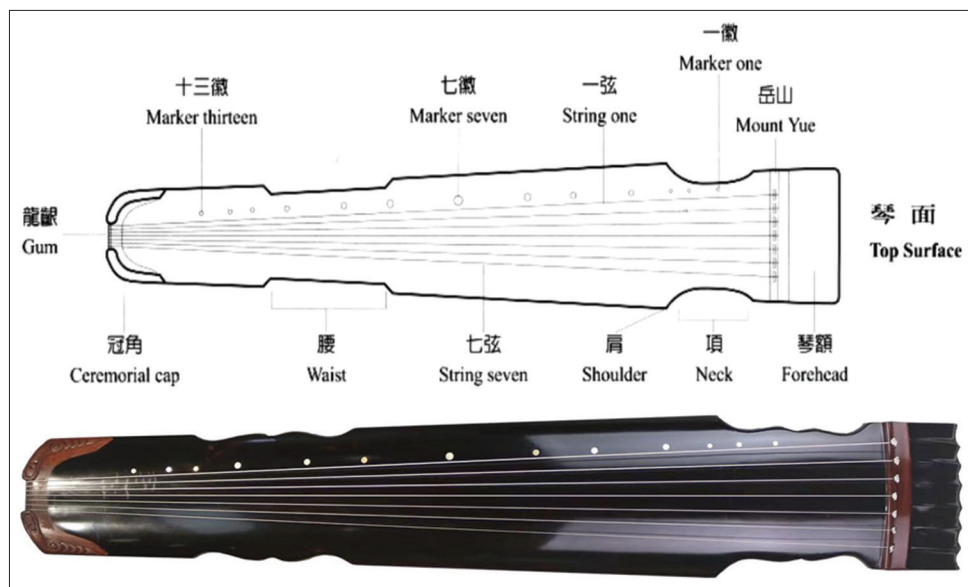


Figure 2. Physical structure of the Guqin (Top surface)

It is carefully contoured and shaped to optimize playability and ergonomics, allowing smooth transitions between notes and chords.

Shoulders and waist

The shoulders and waist of the Guqin are characterized by their distinctive curvature and contour, contributing to the instrument's overall sound and aesthetics. These components are crafted from the same wood as the forehead, neck, and Mount Yue, ensuring consistency in tone and appearance. The curvature of the shoulders and waist is meticulously calibrated to optimize resonance and projection, enhancing the Guqin's tonal richness and clarity.

Markers

Markers are strategically placed along the neck of the Guqin, serving as visual and tactile guides for the musician. These markers indicate the positions of specific notes or intervals, facilitating accurate fingering and intonation during performance. Traditional markers are often made from mother-of-pearl or other decorative materials, adding visual interest to the instrument's fretboard. The placement and spacing of

markers are carefully calibrated to ensure optimal playability and ease of navigation across the instrument's neck.

Strings
